1. Dit personlig danske pas.
2. Dit danske jagttegn og din danske våbentilladelse til de våben du medbringer - i tilgift kan det være en fordel at medbringe dit Europæiske Våbenpas (dette er ikke pålrevet).
3. En præcis adresse for, hvor du skal gå på jagt - fremgår af din invitation til jagten.
4. Den eksport-kopi (B) som du fik i lufthavnen i Danmark, som er stemplet af dansk politi eller toldvæsen.

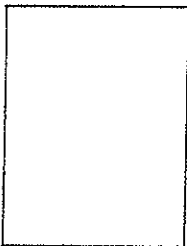
